#### REQUEST FOR BID NO. RFB 2025-141 FLEET MAINTENANCE, REPAIRS AND TOWING RE-SOLICITATION FOR CATEGORIES A & B ONLY

The Englewood Water District (also known as the "District") is requesting sealed bids to secure the services of multiple experienced, competent and responsible Contractors capable of providing as-needed repair, maintenance or towing services, for the District's vehicles, per the specifications in the solicitation package. The work consists of all labor, transportation, services, equipment, materials, supplies, fees and any incidentals associated with performing all work specified in the bid documents. Sealed bids should be mailed or hand delivered to the **Procurement Manager, Englewood Water District, 201 Selma Avenue, Englewood, FL 34223** latest by **2:15 p.m. (ET), May 21, 2025**.

The solicitation was previously advertised and awarded for Category C vehicles, including towing. This is a re-solicitation for Categories A & B vehicles only. References to Category C vehicles are crossed out in this solicitation.

## SPECIAL PROVISIONS

**1) PURPOSE:** It is the intent of the District to establish contracts with up to three (3) responsive and responsible Bidders, meeting or exceeding specifications for preventative maintenance, repair services, and towing for District-owned fleet vehicles, on an as-needed basis. The final number of Bidders awarded will be at the discretion of the District. Per the District's procurement policy, the award will be made on best value, based on but not limited to cost, proximity to the District, experience and qualifications of technicians, services offered and the ability of Bidder to provide services in a timely manner.

**2) PERIOD OF PERFORMANCE:** The initial term of the agreement will be from award until **September 30, 2026**, with four (4) one-year automatic renewals, at the same terms and conditions.

**3) BID PRICE:** Bidders shall submit prices on bid items that they have the capability to provide. Bidders will not be disqualified from award if they do not have the ability to provide services for all line items. Bid price shall be all inclusive covering all costs such as but not limited to all transportation, labor, materials, equipment and any incidentals incurred in performing work as described in the bid documents. Bid prices shall be considered firm from award through **September 30, 2026** for the initial term of the contract award.

**4) PRICE ADJUSTMENT:** Successful Bidders may request a price adjustment at least ninety (90) days before the renewal date of October 1. Only one adjustment per renewal period is allowed. Adjustments are only allowed for bona fide increases to the Bidders' costs to provide the services as identified in this solicitation. Bidders must provide justification for any price adjustments that are acceptable to the District, for any adjustments to be considered. Alternately, the District shall also be entitled to price reductions should the Bidders' costs to provide the services decrease. If no price adjustments are requested within the allowed period, bid prices will remain the same for the renewal period.

In the event that new tariffs, duties, or import restrictions are imposed by any governmental authority after the submission of bids and such tariffs directly result in an increase in prices bid, in the performance of this contract, Bidders may request a price adjustment.

Conversely, if tariffs, duties, or import restrictions affecting bid unit prices are reduced or removed after bid submission and such reduction results in a decrease in the prices, the District shall be entitled to a corresponding reduction in contract prices.

Successful Bidders seeking an adjustment (either increase or decrease) shall provide written notice along with detailed documentation demonstrating the direct impact of the tariff change on prices. Such documentation shall include, but not be limited to, supplier invoices, tariff schedules, or relevant market data.

Any approved price adjustment shall be limited to the actual net change directly attributable to the tariff modification and shall not include any markup or profit. The District reserves the right to verify all submitted documentation and to negotiate the amount of the adjustment, if deemed necessary.

This provision shall apply only to tariffs that take effect after bid submission and shall not apply to pre-existing tariffs already in force at the time of bid submission. The District's decision on any requested price adjustment shall be final.

If the District does not accept the proposed price adjustment, the District retains the discretion to terminate the contract, per the termination clause of the contract.

**5) FORM OF CONTRACT:** The submitted Bid Form signed by the Bidder, together with the complete bid package and any addenda furnished by the District, shall constitute a binding contract. Once the award has been made, the winning Bidder shall be required to perform according to the Bidder's submitted Bid Form and the District's bid package when purchase order numbers by District department have been assigned by and relayed to the Bidder. The purchase order shall serve as both a Notice of Acceptance and Notice to Proceed to the Bidder.

**6) DISTRIBUTION OF WORK:** The selection process used to determine which awarded vendor to send a vehicle to for a specific service will be made when the user department within the District needs the service and will be based on the District's best interest. Each awarded vendor will be part of a pool from which the District's user departments can select

for specific tasks based on their assessment of which vendor best meets the current needs and priorities of the department at that time. It is important to note that being awarded a contract does not guarantee a minimum amount of work. This approach ensures flexibility and responsiveness to our evolving requirements, allowing departments to make decisions that best serve the public interest and support efficient government operations.

**7) STANDARDS:** It shall be the responsibility of the Contractor to assure compliance with any Occupational Safety and Health Administration, (OSHA), Environmental Protection Agency (EPA), Department of Transportation (DOT), National Safety Foundation International (NSF) and other Federal, State, and/or Local rules, regulations, or other requirements, as each may apply.

**8) CONTRACTOR REQUIREMENTS AND QUALIFICATIONS:**

Bidders must have staff that have been ASE (Automotive Service Excellence or equivalent) certified, capable of performing repairs and installations as described in the solicitation. The District retains the right to determine equivalent training or certifications. ~~Bidders that have the capability of servicing larger diesel engines must be certified in diesel and heavy equipment mechanics.~~

Bidders need to have been in the vehicle maintenance business for approximately 3 years.

Any certifications pertinent to the work described herein must be included in the submitted bid, together with a list of technicians who will be working on the District's vehicles and their years of experience. (Submit under Attachment 9 – Other Documentation).

**9) PROFESSIONAL REFERENCES:** As part of the evaluation process, the District may reach out to references, including but not limited to provided references. Bidder's submission of bid constitutes acknowledgment of the process and consent to investigate. The District has the discretion to determine the Bidder's qualifications. If available, please provide 3 professional references for similar work on the provided Reference List (Attachment 2).

**10) QUALITY OF WORK:** The Bidder agrees to do the work covered under this Contract to the best of his/her ability and conforming to this Contract and specifications, and of an acceptable quality to the trades. The Bidder further agrees to follow proper and appropriate instructions from the District.

**11) INVOICES:** Invoices shall be emailed to [apinvoice@englewoodwater.com](mailto:apinvoice@englewoodwater.com). The invoices, shall contain, but not limited to the following information:

- a) The District's vehicle number;
- b) Purchase Order number;
- c) Labor time and charges; and
- d) Itemized parts and materials usage.

**12) GUARANTEE:** The Contractor shall warrant all work performed by him/her, or defects resulting from the use of inferior materials, equipment, or workmanship, for a period of one (1) year from final completion of the work, or written acceptance from the District. Any faulty work will be fully corrected at no cost to the District and restored work will be warranted for one year from the date of acceptance. This will not release additional warranties, if applicable required by other sections.

If any work is found to be defective, the Contractor shall promptly, without cost to the District, and in accordance to the District's written instruction, either correct such defective work, or if it has been rejected by the District, remove it from the site and replace it with non-defective work. If the Contractor does not promptly comply with the terms of such instructions, or in an emergency where delay would cause serious risk of loss or damage, the District may have defective work corrected or the rejected work removed and replaced, and all direct and indirect costs of such removal and replacement, including compensation for any additional professional services shall be paid for by the Contractor.

The making and acceptance of final payment shall not waive any claim for faulty work appearing after final payment or for failure to adhere strictly to the Contract documents. If any part of the work is guaranteed for a longer period, the longer period will prevail.

**13) PERSONAL PROPERTY IN VEHICLES:** To the extent provided by law, the winning bidder shall be accountable and liable for damage or loss to all personal property in the vehicles and for all vehicle accessories.

**14) ADDITIONS AND/OR DELETIONS:** From time to time, as necessitated by change, the District may forward an updated list of the District's vehicles to the Contractor for his records. The Contractor will provide service on any additional vehicle, at the same rate per the same pricing structure under the Contract.

**15) CORRECTION OF WORK BEFORE PAYMENT:** All work and materials shall be subject to the inspection of the District who shall be the final judge of work performed. Should they fail to meet the District's approval, they shall be replaced, and/or corrected by the Contractor at his/her own expense. If any portion of the work pertaining to this Contract was not performed in accordance with the Contract Documents, the compensation to be paid to the Contractor may be delayed until work is satisfactorily corrected, completed and accepted by the District.

**16) AUTHORITY OF THE DISTRICT:** All work shall be performed to the District's satisfaction. It is agreed by the parties hereto that the District shall decide all questions and disputes which may arise relative to the interpretation to the scope of work and fulfillment of the Contract.

The District may examine and inspect the work to ensure compliance with the requirements of the Contract documents, and workmanship relative to the Scope of Work.

The District has the authority to:

- (a) Stop the work, if it is determined that such stoppage may be necessary to ensure the proper execution of the Contract;
- (b) Reject all work that does not conform to the Contract; and
- (c) Resolve all questions that arise in the execution of the work.

**17) SUSPENSION OF WORK:** The District may at any time suspend work by giving ten (10) calendar days' notice or less (per the discretion of the District), to the Contractor in writing. The District shall reimburse the Contractor for expenses incurred by the Contractor in connection with work under the Contract as a result of such suspension, unless such suspension was caused by actions of the Contractor. However, if the work or any part thereof shall be stopped by a notice in writing aforesaid, and if the District does not give written notice to the Contractor to resume work within thirty (30) calendar days of the date fixed in the written notice to suspend, then the Contractor will be entitled to the payment for all work done, unless such suspension was caused by actions of the Contractor.

**18) DISTRICT'S RIGHT TO DO WORK:** If the Contractor should neglect to prosecute the work properly or fail to perform in accordance with the provisions of this Contract, the District, after seven (7) days written notice, may without prejudice to any other remedy it may have, make good any deficiencies and deduct from the payment due the Contractor.

**19) ADDITIONAL INSURANCE – GARAGE KEEPERS:** Successful Bidders shall be responsible for ensuring the vehicle leaves the facility in the same condition as when it arrives. Successful Bidders shall be responsible for repairing any vehicle if the damage was caused while in their care. The successful Bidders must maintain the following additional coverage:

Garage Keepers insurance coverage providing full protection for all damage to the District's vehicle(s) while in the care, custody or control of the contractor or vendor. Such coverage shall cover all loss caused by perils including but not limited to fire, lightning, explosion, theft, mischief, vandalism, collision or overturn.

**20) ADDITIONAL SERVICES:** Additional services shall include services that are not requested in this solicitation, but are within the scope of services available from the awardee(s). The District reserves the right to compete pricing with the successful bidder(s) for additional services or items and to add or not add these services to the awarded items. Additional services are not a factor for award.

**21) CONDITIONS FOR EMERGENCY/HURRICANE OR DISASTER:** It is hereby made a part of this invitation to bid that before, during, and after a public emergency, hurricane, disaster, flood, or acts of God, that the District, shall require a "first priority" basis for goods and services as opposed to a private citizen. It is vital and imperative that the majority of

citizens are protected from any emergency situation which threatens public health and safety, as determined by the District.

## SCOPE OF WORK

**1) INTENT:** It is the District's intent to secure the services of multiple responsive and responsible Bidders meeting or exceeding requirements specified in the solicitation, to provide preventative maintenance and repairs, including towing services for the District's fleet of vehicles, on an as-needed basis. It is anticipated that awards will be made to, up to 3 Bidders based on the District's best interests but the final number of awarded Bidders will be at the sole discretion of the District, depending on its needs.

**2) DISTRICT'S VEHICLES:** Appendix A lists the District's current fleet vehicles and District designated categories. This list may change over time as vehicles are added or sold. Any changes to this list will not affect the contract unit price set forth in the bid form by the Bidder. The District reserves the right to have repairs performed by entities other than the winning bidders, when deemed economically desired, more timely, or otherwise according to the District's best interests.

Categories of the District's vehicles:

Category A (gas engines); and

Category B (diesel engines); and

Category C (larger diesel engines)

**3) LOCATION OF BIDDER'S FACILITY:**

Bidders capable of providing any services (preventative maintenance, repairs or towing) for the District's gas and diesel engines (Categories A and B) shall have at least one established service facility within 10 miles driving distance from Englewood Water District, 201 Selma Ave, Englewood, FL 34223. This shall be successful Bidder's primary location. Bidder shall indicate if any alternate locations shall be used in conjunction with the primary location. Bid prices will be applicable for any alternate locations indicated in the submitted bid.

~~Bidders capable of providing services for towing or for servicing the District's larger diesel engines (Categories C) shall have an established service facility within 50 miles driving distance from Englewood Water District, 201 Selma Ave, Englewood, FL 34223.~~

If available, mobile services for repairs and maintenance within Englewood are desired.

**4) DISTRICT'S CONTACTS:** The vehicles listed in Appendix A, belong to various departments of the District. Upon the award of the bid, the winning Bidders will be provided with a list of the District's contacts, authorized to approve vehicle repairs by department.

**5) PREVENTATIVE MAINTENANCE (OIL CHANGE):**

Preventative maintenance should be conducted in accordance with the original manufacturer's maintenance specifications. Whenever service is completed, an Inspection Report (Appendix B or Appendix C), must be sent to [apinvoice@englewoodwater.com](mailto:apinvoice@englewoodwater.com), including the department manager of the vehicle, with the invoice for payment.

The unit price for oil change (Items 1 and 3 for Categories A & B on Bid Form) will include the labor for inspection, oil filters, fluids, shop supplies, disposal, any fees and incidentals related to performing the work.

Engine oil will not be part of the unit price for oil change but will be a separate charge based on actual usage by the quart at prices bid.

For Categories A and B vehicles, all tires must be inspected during oil change and if needed, rotated per OEM guidelines. The cost for tire rotation will be separate and not included in the unit price for oil change.

Any replacement part(s) shall meet or exceed the manufacturer's original specifications for that vehicle.

Engine oil and oil filters must meet or exceed vehicle manufacturer (OEM) specifications.

All fluid levels must be topped off with fluids of equal or which exceeds vehicle manufacturer (OEM) specifications.

Used by-products of any service shall be disposed in accordance with all Federal, State, and Local regulations, and included in the bid price. No additional disposal fees or shop supplies shall be paid by the District.

**Any recommended repairs/replacement of parts stemming from the vehicle inspection, must be approved in advance, by authorized personnel at the District, see 4) DISTRICT'S CONTACTS.**

**6) TIRES:** A major inspection of the tires shall be performed at each service. Individual department managers of the District, see **4) DISTRICT'S CONTACTS** below, shall be notified when the tread depth reaches 4/32" on the front tires and 2/32" on rear tires. The District reserves the right to utilize other vendors for the purchase of tires, to meet the needs of the District. All new tires may be purchased through a supplier that offers state or cooperative contract prices for government agencies.

**7) PARTS & MATERIAL PRICING:** The Bidder shall base its pricing on a percentage mark-up from Bidder's cost. The District reserves the right to request proof of Bidder cost on any parts or materials ordered. **Shop supplies are a no cost item to the District.** All parts and material provided must meet or exceed OEM specifications. **The Bidder shall be responsible for the proper disposal of used fluids, filters, and other items with no additional cost to the District** and in accordance with all current state, local, health and safety regulations, which includes full Compliance with Environmental Protection Agency (EPA) guidelines for the disposal of hazardous material.

**8) REPAIRS:** **All repairs, regardless of amount, shall be communicated to the authorized personnel at the District for approval prior to performing work, see 4) DISTRICT'S CONTACTS.** Repairs shall be based on new or undamaged parts on damaged vehicles. Any additional repairs discovered during the course of repairing a vehicle, will need prior approval from authorized District personnel before work can be done. The Contractor shall respond to requests for repairs in a timely manner and provide a written or verbal estimate of the date when the vehicle shall be returned.

**9) REPLACEMENT COMPONENTS:** The bidder shall use new components that meet or exceed OEM standards when repairing the District's vehicles. If any used components are utilized, they are required to be authorized by the District's representative(s) prior to installation. The District may also require the winning bidder to install parts or materials provided by the District. These parts and materials may be new or used. The bidder shall charge the District the labor rate submitted on the Bid Form for the installation of these parts.

**10) LABOR RATES FOR MAINTENANCE AND REPAIRS:** Labor rates quoted are all inclusive. The District will not allow a separate trip charge on any onsite visits or pay for travel time to or from any worksite.

**11) AVAILABILITY:** The Bidder will provide service five (5) days a week, Monday through Friday, excluding nationally recognized holidays. Bidder shall be available to perform the service during regular business hours.

**12) RESPONSE TIME:** The District shall notify the awarded Contractor(s) to schedule the service request if an appointment is required. The awarded Contractor(s) shall be required to perform full preventative maintenance vehicle service and safety inspection on any District-owned vehicle specified under this contract within seven (7) calendar days of initial service request. Service time for routine maintenance shall not exceed 48 hours. The District will make every effort to have the vehicle at the awarded Contractor's place of business prior to the scheduled service appointment. The District reserves the right to cancel or reschedule any service appointment at no cost to the District.

**13) TOWING SERVICE:** This service covers towing the District's disabled fleet vehicles (see Appendix A for the District's vehicle categories) to a repair shop that is capable of repairing the vehicle. Service during regular hours will be considered Bidder's regular business hours. Service after regular hours would be outside of Bidder's regular business hours. The awarded bidder(s) shall be required to dispatch a driver within thirty (30) minutes from the time a call is placed. If unable to meet the response time, the District may contact another vendor from the awarded vendor list. All items, attached or

loose, to equipment need to be secured prior to towing to prevent damage or loss. Contractors shall be liable for any damages or loss caused by the negligence of Contractor.

**14) SUBCONTRACTING:** The bidder remains fully accountable for the completion of work in this solicitation, at prices bid, even if portions of the work are performed by subcontractors. Nothing contained in the contract documents shall create any contractual relationship between any subcontractor and the District.

## INSTRUCTIONS TO BIDDERS AND GENERAL PROVISIONS

**1) QUALIFICATIONS OF BIDDER:** The District intends to award the Contract, to multiple responsive and responsible Bidder(s), qualified by experience, proven reliability, the ability to provide the services or items required under this bid, within a reasonable time frame acceptable to the District. Bidder(s) may be required to supply information in writing at the request of the District prior to bid award, to verify above requirements.

**2) EXAMINATION OF BID DOCUMENTS:** Prior to the submission of a bid, Bidders will carefully examine the Special Provisions, Scope of Work, Instructions to Bidders and General Provisions, Insurance Requirements, and all other related bid documents, including any and all modifications, incorporated into the bid package. They should also fully inform themselves as to all existing conditions and limitations that affect the scope of work performed under this Contract.

The bid package will be posted on [www.demandstar.com](http://www.demandstar.com) and on the Purchasing section on the District's website [www.englewoodwater.com](http://www.englewoodwater.com). It is the Bidder's responsibility to view the bid package on either platform and download all issued addenda or to contact the District to determine if addenda were issued.

**4) CLARIFICATION AND ADDITIONAL INFORMATION:** Discrepancies, omissions, or questions about the intent of the documents will be submitted by e-mail to **Bee Ling Wheaton**, Procurement Manager at the District at [bwheaton@englewoodwater.com](mailto:bwheaton@englewoodwater.com), requesting interpretation by **5:00 p.m. on May 13, 2025**. Only responses issued by the District through addendums will be legally binding.

Interpretations made will be in the form of an addendum to the documents, which will be posted on [www.demandstar.com](http://www.demandstar.com) and on the Purchasing section on the District's website [www.englewoodwater.com](http://www.englewoodwater.com). Bidders must acknowledge receipt of any addendum on the bid form, indicating the addendum number and date of issue, therein becoming part of the Contract. The District will attempt to notify all prospective Bidders of addenda issued to the bid documents, however, it shall be the responsibility of the Bidder, prior to submitting their bid, to contact the District, to determine if any addenda were issued, acknowledging and incorporating said addenda into their bid.

**5) MODIFICATION OR WITHDRAWAL OF BIDS:** Bidders may submit an amended bid before the opening of bids. Such amended bids must be a complete replacement for a previously submitted bid and must be clearly identified as such, signed by authorized personnel of the Bidder's company.

Bids may only be withdrawn by written request from the Bidder before bid opening. Error or negligence on the part of the Bidder in bid preparation does not constitute the right for withdrawal of the bid after it has been opened.

**6) NO BID:** A respondent who is on the bid notification list and decides not to submit a response is requested to complete the Statement of Non-Submittal Form and return it to the District by e-mail to [bwheaton@englewoodwater.com](mailto:bwheaton@englewoodwater.com).

**7) CONFLICTS WITHIN SOLICITATION:** Where there appears to be a conflict between the Special Provisions, Scope of Work, Instructions to Bidders and General Provisions, the Bid Form, or any addendum issued, the order of precedence shall be: the last addendum issued, the Bid Form, the Special Provisions and Scope of Work, Instructions to Bidders and General Provisions. It is incumbent upon the Bidder to identify such conflicts to the designated purchasing representative prior to the bid or proposal response date.

**8) ADDITIONAL TERMS:** When submitting a solicitation response, Bidders must not attach any forms, proposals, or documents which contain terms and conditions of the Respondent. The inclusion of additional terms and conditions, even if a part of the Bidder's standard forms, may result in the solicitation response being declared non-responsive and rejected as these added terms and conditions are considered a counteroffer to the District's solicitation. If the Bidder desires to take exception(s) to any portion of the terms and conditions of this bid, the exception(s) must be taken during the Request for Clarification and Additional Information period.

**9) PAYMENT:** Payment will only be made after inspection and approval of the District of the work performed. It is the policy of the District that payment for all purchases by the District shall be made in accordance with Part VII, Chapter 218, Florida Statutes, known as the Local Government Prompt Payment Act. The Bidder may offer cash discounts for prompt payments; however such discounts will not be considered in determining the lowest price during bid evaluation.

**10) PREPARATION AND SUBMISSION OF BID FORM REQUIREMENTS:**

**Bid Form:** Bids shall be made on forms supplied by the District, or as otherwise specified. Each bid must state the name of the Bidder, the Bidder's full business address and state the type of business entity, followed by the original signature and designation of the officer or authorized personnel to bind the corporation. Any erasures or other corrections in the bid form must be explained or noted over the signature of the Bidder. Bid forms containing any conditions, omissions, unexplained erasures, alterations, or irregularities of any kind may be rejected by the District.

**Bid Bond: (NOT APPLICABLE FOR RFB 2025-141)** Each bid must be accompanied by a Bidder's bond with their bid in the amount of NOT LESS THAN 5% of their total amount of the bid. This security shall ensure that the Bidder does not revoke the bid after bid opening, or fails to execute any necessary additional documents.

**Bid Documents:** Bid documents and forms shall be submitted sealed to the Procurement Department at **Englewood Water District**, 201 Selma Ave, Englewood, FL 34223. The envelope/package shall be clearly marked with the Bid Number, Name and Business Address of the Bidder. One hard copy of the bid, as well as an electronic copy in pdf format on a USB flash drive shall be provided to the District.

Submission of a response constitutes a binding offer and shall be subject to all terms and conditions specified in the bid package.

For your bid to be acceptable, **all blank spaces** must be completed as requested. All bids must contain a **manual** signature of the authorized representative of the Bidder in the space provided on the Bid Certification Form.

Responsibility for getting this bid to the District on or before the specified date and time is solely the responsibility of the Bidder. The District will not be responsible for any delay, for any reason whatsoever. Bids must be received and stamped with the date and time on the outside of the envelope, and must be at District by the date and time specified for opening.

**Bid Guarantee:** The bid form shall be signed where indicated constituting an agreement that the Bidder will not withdraw his/her bid for a period of ninety (90) days after the opening of the bids.

**Expenses Incurred in Preparing Bid:** The District accepts no responsibility for any expenses incurred by the Bidder in the preparation and submission of a bid. Such expenses shall be borne exclusively by the Bidder.

**Bid Corrections & Erasures:** Any erasures or other corrections in the bid must be explained or noted over the signature of the Bidder. Bid forms containing any conditions, omissions, unexplained erasures, alterations, or irregularities of any kind may be rejected at the discretion of the District.

**Bid Opening:** All bids received by the date and time so specified shall be opened and **the name of each Bidder will be read aloud** within the designated room at the District, during bid opening. It is optional for Bidders and the general public to be present at the bid opening.

**Late Bids:** Bids received after the date and time of bid opening will not be considered. It will be the Bidder's responsibility to make arrangements for the return of the bid package at their own expense. Bid packages will be discarded, if unclaimed 7 calendar days after bid opening. Bids postmarked prior to said date and time but not received shall also not be considered.

**11) DISTRICT RIGHTS:** The District reserves the right to accept or reject any and/or all bids in whole or in part, split the award, to waive irregularities and technicalities, and to request resubmission with or without cause and/or to accept the bid that, in its judgment, will be in the best interest of the District. Also, the District reserves the right to accept all or any part of the bid and to increase or decrease quantities to meet additional or reduced requirement of the District. If only one response is received, the District has the discretion to accept or reject the bid, or begin negotiations, depending on available competition and the timely needs of the District.

**12) AWARD OF BID:** The award of this bid may be in total or in part, to multiple, responsive, responsible bidders, capable of providing services as indicated in this solicitation, whichever is deemed to be in the best interests of the District. At its sole discretion, the District reserves the right to award by line, group of lines or in total. Any unfavorable reference may be cause to deem a bidder non-responsive. The District reserves the right to reject the bid of any Bidder who has previously failed to perform properly, or on time, contracts of similar nature; or who is not in a position to satisfactorily perform the contract. Bidders will not be disqualified from award if they are not able to bid on all items in the bid.

**13) ERRORS:** For the initial evaluation of bids, the following will be utilized in resolving arithmetic discrepancies found on the Bid schedule as submitted by Bidders:

1. Obviously misplaced decimal points will be corrected;
2. In case of discrepancy between unit price and extended price, the unit price will prevail. Apparent errors in extension will be corrected;
3. Apparent errors in addition of lump sum and extended prices will be corrected; and
4. For the purpose of the bid evaluation, the District will proceed on the assumption that the Bidder intends his/her bid be evaluated on the basis of the unit prices, extensions, and totals arrived at by resolution of arithmetic discrepancies as provided above and the bid will be so reflected on the tabulation of bids.

**14) BID TABULATIONS:** Pursuant to Florida Statute §119.071(1)(b)2, all bid tabulations shall be posted on the District's website <https://englewoodwater.com/legal-notices-purchases/> and also DemandStar's website at [www.demandstar.com](http://www.demandstar.com) within thirty (30) days after bid opening or when the District provides notice of a decision or intended decision, whichever is earlier.

**15) FORM OF CONTRACT:** The Bidder's response, together with the bid package and any addenda furnished by the District and Purchase Order, shall constitute a binding contract. The successful Bidder shall be required to perform according to the submitted Bid Form and the District's solicitation package when a Purchase Order number is provided to the winning Bidder. The transmitted Purchase Order shall serve as both a Notice of Acceptance and a Notice to Proceed to the Contractor.

**16) WARRANTY:** All warranties express and implied, shall be made available to the District for goods and services covered by this bid package. All goods furnished shall be fully guaranteed by the Contractor against factory and workmanship defects. At no expense to the District, the Contractor shall correct any and all apparent and latent defects that may occur within the manufacturer's standard warranty period. The special conditions of the bid package (if applicable) may supersede the manufacturer's standard warranty.

**17) DESCRIPTIVE INFORMATION:** Unless otherwise specifically provided in the Special Provisions and Scope of Work, if applicable, all equipment, parts, materials and articles incorporated in the work covered by this Contract are to be new and of the most suitable grade for the purpose intended. Unless otherwise specifically provided in the Scope of Work, reference to any equipment, part, material, article or patented process, by trade name, make or catalog number, shall be regarded as establishing a standard of quality and shall not be construed as limiting competition. If the Bidder wishes to make a substitution to the specifications, the Bidder shall furnish the District the name of the manufacturer, the model number and other identifying data and information necessary to aid in the District in evaluating the substitution. Such substitution shall be subject to District approval. Substitutions shall be approved only if determined by the District to be equivalent to the specifications. A bid containing substitution is subject to disqualification if the District does not approve the substitution.

**18) TAXES/FREIGHT:** If applicable, the bid shall include any freight, handling, delivery, surcharges or other incidental charges. Unless otherwise specified in the bid package, prices quoted shall be F.O.B. Destination. The District is exempt from the payment of Federal and State taxes, including sales tax. The bid offer shall not include sales tax to be collected from the District. The District's sales tax exemption is not available to the Contractor for items the Contractor purchases, regardless of whether these items will be transferred to the District.

**19) CONTINUATION OF WORK:** Any work that commences prior to and will extend beyond the expiration date of the current Contract period shall, unless terminated by mutual written agreement between the District and the Contractor, continue until completion without change to the then current prices, terms and conditions.

**20) CONTRACT CONTINUITY/TRANSITIONAL PERIOD:** In the event the services are scheduled to end either by Contract expiration or by termination by the District (at the District's discretion), the Bidder may continue the services, with mutual written agreement, if requested by the District, until new services can be completely operational. At no time shall this transitional period extend more than six (6) months beyond the expiration date of the existing Contract. The Bidder will be reimbursed for this service at the rate in effect when this transitional period clause is invoked by the District.

**21) TERMINATION OF AGREEMENT:**

(a) For Convenience. The District may terminate this Agreement at any time without cause by providing the Contractor with thirty (30) calendar days advance notice in writing, delivery by email is acceptable. In the event of termination for convenience, all finished or unfinished deliverable items prepared by the Contractor under this Agreement shall, at the option of the District, become the District's property. If the Agreement is terminated for convenience by the District as provided herein, the Contractor shall be paid for services satisfactorily completed, less payment or compensation previously made. Except as otherwise directed, the Contractor must cease all work on the date of receipt of the notice of termination.

(b) For Cause or Default. If, through any cause, the Contractor should fail to fulfill in a timely and proper manner its obligations under this Agreement, other than for the instances listed below due to "Force Majeure", the District will have the right to terminate this Agreement by providing a written notice (Show Cause Notice) to the Contractor requiring a written response due within five (5) calendar days from receipt of the written notice as to why the Agreement should not be terminated for default. The District's Show Cause Notice shall include an Agreement termination date at least seven (7) calendar days after the due date for the Contractor's response. Should the Contractor fail to respond to such show cause notice, or if the District determines that the reasons provided by the Contractor for failure of the Contractor to fulfill its contractual obligations do not justify continuation of the contractual relationship, the Agreement shall be considered to have been terminated for default on the date indicated in the Show Cause Notice.

In the event that the District terminates the contract for default, all finished or unfinished deliverable items under this contract prepared by the Contractor shall, at the option of the District, become District property, and the Contractor shall be entitled to receive just and equitable compensation for any satisfactory work completed on such materials. Notwithstanding this compensation, the Contractor shall not be relieved of liability to the District for damages sustained by the District by virtue of any breach of this Agreement, and the District may withhold any payment due the Contractor for the purpose of set-off until such time as the exact amount of damages due the District from such breach can be determined.

The District reserves the right to terminate this contract, in part or in whole, in the event the Contractor fails to perform in accordance with the terms and conditions stated herein. The Contractor will be notified by letter of the District's intent to terminate. In the event of termination for default, the District may procure the required goods and/or services from any source and use any method deemed in its best interest. All re-procurement costs shall be borne by the Contractor.

Upon the Contractor filing a petition for bankruptcy or the entering of a judgment of bankruptcy by or against the Contractor, the District may immediately terminate, for cause, this Agreement and all other existing agreements the Contractor has with the District and debar the Contractor from doing future business with the District.

Upon receipt of a termination action, for convenience or cause, the Contractor shall promptly discontinue all affected work (unless the notice directs otherwise) and deliver or otherwise make available to the District all data, drawings, reports

specifications, summaries and other such information, as may have been accumulated by the Contractor in performing this contract, whether completed or in process.

(c) **Termination by Contractor.** Contractor shall have the right to terminate services only in the event of the District failing to pay the Contractor's properly documented and submitted invoice within ninety (90) calendar days after the invoice has been approved by the District, or if the project is suspended by the District for a period greater than ninety (90) calendar days.

**22) RULES, REGULATIONS & LICENSES:** The Contractor shall comply with all federal, state, and local laws and regulations applicable to provision of goods and/or services specified in this bid package. It shall be the responsibility of the Contractor to ensure compliance with OSHA, EPA, and/or other local, federal, or State of Florida rules, regulations or other requirements, as applicable. The Contractor must be authorized to transact business and be properly licensed in the State of Florida.

When applicable and as required by law, the Contractor will provide a material safety data sheet with each delivery of a toxic substance.

**23) PROPRIETARY OR CONFIDENTIAL INFORMATION:** In accordance with Chapter 119 of the Florida Statutes (Public Records Law) and except as may be provided by other applicable State and Federal Law. All bidders should be aware that the bidder's submittal is in the public domain. However, the bidders are required to identify specifically any information contained in their submittal package, which they consider confidential and/or proprietary and which they believe to be exempt from disclosure, and specifically cite the applicable exempting law.

**24) MAINTENANCE OF RECORDS:** The Contractor shall maintain books, records, and other documents pertaining to, or connected with this contract. All records will be made available and accessible at the Contractor's offices for the purpose of inspection, audit and copying during normal business hours by the District, or any of its authorized representatives. Retention time for these records shall be for a minimum of five (5) years after the conclusion of this agreement.

**25) CODE OF ETHICS:** With respect to this bid, if any Bidder violates or is a party to a violation of the Florida Statutes, Chapter 112, Part III, Code of Ethics for Public Officers and Employees, such Bidder may be disqualified from furnishing the goods or services for which the bid is submitted and shall be further disqualified from submitting any future bids for goods or services for the District.

**26) COLLUSION:** By submitting this bid, the Bidder certifies that he/she has not divulged to, discussed or compared his/her bid with other Bidders and has not colluded with any other Bidder or parties to this bid whatsoever. Also, Bidder certifies, and in the case of a joint bid each party thereto certifies as to his/her own organization, that in connection with this bid: any prices and/or cost data submitted have been arrived at independently, without consultation, communication, or agreement, for the purpose of restricting competition, as to any matter relating to such prices and or cost data, with any other Bidder or with any competitor; any prices and/or data quoted for this bid have not been knowingly disclosed by the Bidder and will not knowingly be closed by the Bidder prior to the scheduled opening directly or indirectly to any other Bidder or to any competitor; no attempt has been made or will be made by the Bidder to induce any other person or firm to person or persons interested in this bid, principal or principals is/are named therein and that no person other than therein mentioned has any interest in this bid or in the Contract to be entered into; and no person or agency has been employed or retained to solicit or secure this Contract upon an agreement or understanding for a commission, percentage, brokerage, or contingent fee excepting bona fide employees of the Bidder.

**27) PUBLIC ENTITY CRIMES:** In accordance with Florida Statutes Sec. 287.133(2)(a), "A person or affiliate who has been placed on the convicted vendor list following a conviction for a public entity crime may not submit a bid on a Contract to provide any goods/services to a public entity, may not submit a bid on a Contract with a public entity for construction or repair of public building or public work, may not submit bids on leases of real property to a public entity, may not be awarded or perform work as a Contractor, supplier, subcontractor, or consultant under a Contract with any public entity, and may not transact business with any public entity in excess of the threshold amount provided in Sections 287.017, for Category Two, for a period of 36 months from the date of being placed on the convicted vendor list." By submitting a bid, vendor certifies that vendor is not currently prohibited from transacting business with the District due

to the above statute. The vendor shall comply with the terms of this statute both before and during the term of this Contract.

**28) INDEPENDENT CONTRACTOR:** The Contractor shall legally be considered an independent contractor and neither the Contractor or any of its employees shall, under any circumstances be considered employees or agents of the District. The District shall at no time be legally responsible for any negligence or other wrongdoing by the Contractor, employees or its agents. The District shall not withhold from the Contractor any Federal or State unemployment taxes, Federal or State income taxes, Social Security tax, or any other amounts for benefits to the Contractor. Further, the District shall not provide to the Contractor any insurance coverage, or other benefits, including workers' compensation, normally provided by the District for its employees.

**29) SUBCONTRACTING:** ~~Unless otherwise specified in this solicitation, the Contractor shall not subcontract any portion of the work without the prior written consent of the District. Subcontracting without prior consent of the District may result in termination of the Contract for default. If subcontracting is permitted by the District, the Contractor agrees that his/her company is as fully responsible to the District for the acts and omissions of his Subcontractors and of persons either directly or indirectly employed by them as he/she is for the acts and omissions of persons directly employed by him/her. Nothing contained in the Contract documents shall create any Contractual relationship between any Subcontractor and the District.~~

**30) MODIFICATION OF CONTRACT:** Any Contract resulting from this bid package may be modified by mutual consent of duly authorized parties, in writing through the issuance of a modification to the Contract and/or change order as appropriate.

**31) SUCCESSORS AND ASSIGNS:** The vendor shall not assign any interest in any Contract resulting from this bid package and shall not transfer any interest in same (whether by assignment or novation) without prior written consent of the District, except that claims for the money due or to become due to the vendor from the District under any Contract may be assigned to a financial institution or to a trustee in bankruptcy without such approval from the District. Notice of such transfer or assignment due to bankruptcy shall be promptly given to the District.

**32) CONFLICTS OF INTEREST – DISTRICT OFFICERS, EMPLOYEES OR BOARD MEMBERS:** The Florida Code of Ethics regulates the ability of the District to contract with its public officers (including board members), employees, and their immediate relatives. Respondents shall disclose any such potential conflicts on the provided Conflict of Interest Form. Respondents are responsible for reviewing Florida Statute §112.313 to determine whether they may have a conflict. If Respondent is in doubt as to their ability to contract with the District, they shall seek a conflict of interest opinion from the District's Administrator or his/her designated representative prior to submittal of a response. Attachment X – Conflict of Interest Form needs to be completed and submitted with the bid.

**33) TRUTH-IN-NEGOTIATIONS CERTIFICATE:** If applicable, execution and signature by the vendor of the Bid Form shall act as the execution of a truth-in-negotiation certificate certifying that the wage rates and costs used to determine the compensation provided for in this Contract are accurate, complete, and current as of the date of the Contract.

For professional service Contracts, the original Contract price and any additions thereto will be adjusted to exclude any significant sums by which the District determines the Contract price was increased due to inaccurate, incomplete, or noncurrent wage rates and other factual unit costs. The District shall exercise its rights under this "Certificate" within one (1) year following payment. NOT APPLICABLE FOR THIS BID.

**34) STATE REGISTRATION REQUIREMENTS:** Any Bidder required by Florida law to register to do business in this state shall either be registered or have applied for registration with the Florida Department of State in accordance with the provisions of Chapter 607, 608, 617, or 621, Florida Statutes, unless they are exempt. A copy of the registration/application may be required prior to award of a contract. Any partnership submitting a bid in response to this RFB shall have complied with the applicable provisions of Chapter 620, Florida Statutes.

**35) PERFORMANCE EVALUATION:** At the end of the Contract, the District may evaluate the successful Bidder's performance. This evaluation shall become public record.

36) **NON-EXCLUSIVE CONTRACT:** Award of this Contract shall not require the District to use the Vendor for all work of this type, which may develop during the Contract term. This Contract is non-exclusive. The District reserves the right to concurrently Contract with other entities for similar work if it deems such action to be in the best interests of the District.

37) **CONTACT PROHIBITION:** All prospective Bidders are hereby instructed **NOT** to contact any board member of the District, or any District staff member other than the Authorized Contact Persons, identified in this Bid package regarding this solicitation package, Bidder's submittal package, the District's Intent to Award, or the District's Intent to Reject (if applicable) at any time prior to the formal award for this project. Any such contact shall be cause for rejection of your submittal.

38) **CONTRACTING WITH DISTRICT EMPLOYEES OR BOARD MEMBERS:** Any District employee, Board member or member of his or her immediate family seeking to Contract with the District shall seek a conflict of interest opinion from the Administrator or their designated representative prior to submittal of a response or application of any type to Contract with the District. The affected employee or Board member shall disclose his or her assigned function within the District and interest or the interest of his or her immediate family in the proposed Contract and the nature of the intended Contract.

Florida Statute §112.313(12) Standards of Conduct for Public Officers, Employees of Agencies, And Local Government Attorneys controls contracting with The District employees or board members, and provides as follows:

(12) EXEMPTION --The requirements of subsections (3) and (7) as they pertain to persons serving on advisory boards may be waived in a particular instance by the body which appointed the person to the advisory board, upon a full disclosure of the transaction or relationship to the appointing body prior to the waiver and an affirmative vote in favor of waiver by two-thirds vote of that body. In instances in which appointment to the advisory board is made by an individual, waiver may be effected, after public hearing, by a determination by the appointing person and full disclosure of the transaction or relationship by the appointee to the appointing person. In addition, no person shall be held in violation of subsection (3) or subsection (7) if:

(b) The business is awarded under a system of sealed, competitive bidding to the lowest or best Bidder and:

1. The official or the official's spouse or child has in no way participated in the determination of the bid specifications or the determination of the lowest or best Bidder;
2. The official or the official's spouse or child has in no way used or attempted to use the official's influence to persuade the agency or any personnel thereof to enter such a contract other than by the mere submission of the bid; and
3. The official, prior to or at the time of the submission of the bid, has filed a statement with the Commission on Ethics, if the official is a state officer or employee, or with the supervisor of elections of the county in which the agency has its principal office, if the official is an officer or employee of a political subdivision, disclosing the official's interest, or the interest of the official's spouse or child, and the nature of the intended business.

39) **PUBLIC RECORDS:** Pursuant to Florida Statute §119.071(1)(b)(2), all bid documents are exempt from public record until such time as the District provides notice of an intended decision or until 30 days after opening the bids, whichever is earlier.

The Contractor shall comply with Florida public records laws, and shall specifically:

- (a) Keep and maintain public records that ordinarily and necessarily would be required by the District for the service to be performed.
- (b) Upon request from the District, provide the District, at no cost, with a copy of the requested records or allow the records to be inspected or copied within a reasonable time at a cost that does not exceed the cost provided for by law. All records kept electronically must be provided to the District, upon request, in a format that is compatible with the information technology systems of the District.
- (c) Ensure that public records that are exempt or confidential and exempt from public records disclosure requirements

are not disclosed except as authorized by law.

(d) Meet all requirements for retaining public records and transfer, at no cost, to the District all public records in possession of the Contractor upon termination of the Agreement and destroy any duplicate public records that are exempt or confidential and exempt from public records disclosure requirements. If the Contractor keeps and maintains public records upon the completion of the contract, the Contractor shall meet all applicable requirements for retaining public records.

Failure of the Contractor to comply with these requirements shall be a material breach of this Agreement.

**40) PROTESTS:** Protests can only be made by Parties that submitted a bid to the District's solicitation. Protests must be submitted in writing to the Procurement Manager at bwheaton@englewoodwater.com, no later than three (3) business days after the day the Notice of Recommendation to Award is published and distributed. Protests may be sent by certified mail or submitted by electronic mail. The written protest must specifically state the reason for the protest and exactly what is being protested. Protests received after the deadline will not be considered. The Procurement Manager will respond to protests no later than seven (7) business days from the day it is received. In the event of a protest the determination and decision of the District's Administrator shall be final. Any and all costs incurred by a protesting party associated with a protest shall be the sole responsibility of the protesting party.

**41) FORCE MAJEURE:** The parties will exercise every reasonable effort to meet their respective obligations hereunder, but shall not be liable for delays resulting from force majeure or other causes beyond their reasonable control, including, but not limited to, compliance with any Government law or regulation, acts of nature, acts or omissions of the other party, Government acts or omissions, fires, strikes, national disasters, wars, riots, transportation problems and/or any other cause whatsoever beyond the reasonable control of the parties. The non-performing party shall provide written notice within five (5) days of the event of force majeure, describing the event in sufficient detail, provide a good faith estimate of the duration of the delay, proof of how the event has precluded the non-performing party from performing, and the means and methods for correcting the delay; and continues to furnish timely reports of all actions required for it to commence or resume performance of its obligations under this agreement. The economic hardship of a party does not constitute an event of force majeure. A party will not be excused from performance due to forces that it could have reasonably prevented, removed or remediated prior to, during, or immediately after their occurrence.

The non-performing party's affected obligations under this agreement will be temporarily suspended during, but not longer than, the continuance of the event of force majeure and a reasonable time thereafter as may be required to commence or resume performance of its obligations. Notwithstanding the above, performance shall not be excused under this section for a period exceeding two (2) months, provided that in extenuating circumstances, the District may excuse performance for a longer term. The term of this Contract will be extended by a period equal to that during which the non-performing party's performance is suspended under this Section.

**42) GOVERNING LAW AND VENUE:**

The rights, obligations and remedies of the parties under this Contract shall be governed by the laws of the State of Florida and the exclusive venue for any legal or judicial proceedings in connection with the enforcement or interpretation of this Contract shall be in Sarasota County, Florida.

**43) UNAUTHORIZED ALIEN WORKERS:** The District will not intentionally award publicly-funded contracts to any Contractor who knowingly employs unauthorized alien workers. Per Florida Statutes 448.09, Unauthorized aliens, employment prohibited and 8 USC 1324a Unlawful employment of aliens, it is unlawful for any person knowingly to

employ, hire, recruit, or refer, either for herself or himself or on behalf of another, for private or public employment, an alien who is not duly authorized to work by the immigration laws or the Attorney General of the United States.

**44) E-VERIFY:** The District, Contractor and every subcontractor shall register with and use the E-Verify system of the United States Department of Homeland Security to verify the work authorization status of all new employees are required by Section 448.095, Florida Statutes. A Contractor who enters into a contract with a subcontractor must require that the subcontractor provides the Contractor a certification by affidavit stating that at the time of such certification and during the terms of the contract, the subcontractor does not and will not employ, contract, or subcontract with an unauthorized alien, who is not authorized under federal law to be employed in the United States, as described in 8 U.S.C.S.1324A(H)(3). The Contractor shall comply with all other federal laws pertaining to the subcontractor. Failure to comply with the state law requirements can result in the District's termination of the contract and other penalties as provided by law.

**45) NON-DISCRIMINATION:** The District does not discriminate on the basis of race, color, national origin, sex, age, disability, family or religious status in administration of its programs, activities or services. Pursuant to F.S. §287.134(2)(a), an entity or affiliate who has been placed on the discriminatory vendor list may not submit a bid, proposal, or reply on a contract to provide any goods or services to a public entity; may not submit a bid, proposal, or reply on a contract with a public entity for the construction or repair of a public building or public work; may not submit bids, proposals, or replies on leases of real property to a public entity; may not be awarded or perform work as a Contractor, supplier, subcontractor, or consultant under a contract with any public entity; and may not transact business with any public entity.

**46) EQUAL EMPLOYMENT OPPORTUNITY:** The District, in accordance with the provisions of Title VII of the Civil Rights Act of 1964 (78 Stat. 252) and the Regulations of the Department of Commerce (15 CFR, Part 8) issued pursuant to such Act, hereby notifies all Bidders that it will ensure that in any Contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit replies in response to this advertisement and will not be discriminated against on the ground of race, color or national origin in consideration for an award.

**47) DRUG FREE WORKPLACE PREFERENCE:** The District requests that the attached Drug Free Workplace Form accompany the bid response. The District will not disqualify any Bidder who does not sign the form. The Drug Free Workplace form is primarily used as a tie breaker when two or more separate entities have submitted bids at the same price, terms and conditions, with preference given to the Bidder who has signed the form.

**48) SCRUTINIZED COMPANIES:**

(a) Certification. As required by Florida Statutes Section 287.135(5), for contracts of any amount, the Contractor must certify on a form provided by the District, that it is not on the Scrutinized Companies that Boycott Israel List, created pursuant to Florida Statutes Section 215.4725, and that it is not engaged in a boycott of Israel.

(b) Requirements. As required by Florida Statutes Section 287.135(5), for contracts of \$1,000,000 or more, the Contractor must certify on a form provided by the District, that all of the following are true:

1. The Contractor is not on the Scrutinized Companies that Boycott Israel List, created pursuant to Florida Statutes Section 215.4725, and that it is not engaged in a boycott of Israel; and

2. The Contractor is not on the Scrutinized Companies with Activities in Sudan list or the Scrutinized Companies with Activities in Iran Petroleum Energy Sector list, created pursuant to Florida Statutes Section 215.473; and

3. The Contractor is not engaged in business operations in Cuba or Syria.

(c) Termination. If the Contractor provides a false certification or has been placed on one of the above-noted Lists of Scrutinized Companies or has engaged in business operations in Cuba or Syria, the Contractor will be in breach of this Contract and the District may terminate this Contract.

(d) Penalty.

1. A Contractor that has been found to have provided a false certification may be subject to a civil penalty equal to the greater of \$2 million or twice the amount of this Contract, plus all reasonable attorneys' fees and costs, including any costs for investigations that led to the finding of the false certification; and

2. Will be ineligible to bid on any contract with the District for three (3) years after the date the District determined that the Contractor submitted a false certification.

**49) PROHIBITION AGAINST CONSIDERING SOCIAL, POLITICAL OR IDEOLOGICAL INTERESTS IN GOVERNMENT CONTRACTING:**

**CONTRACTING:** Respondents are hereby notified of the provisions of section 287.05701, Florida Statutes, as amended, that the District will not request documentation of or consider a Respondent's social, political, or ideological interests when determining if the Respondent is a responsible contractor. Respondents are further notified that the District may not give preference to a Respondent based on the Respondent's social, political, or ideological interests.

**50) GRANT FUNDING:** In the event any part of the Contract is to be funded by federal or state funds, the Contractor agrees to comply with all Federal terms, conditions, provisions, certifications, affidavits, or otherwise as applicable according to the requirements of the funding entity applicable to the use of the monies, including full application of requirements involving the use of minority firms, women's business enterprises, and labor surplus area firms. Contractors shall assist with the submission of all required forms and documents as part of the grant funding requirements. The Contractor further agrees to incorporate all such clauses, provisions, and regulations into any sub-contracted agreements or relationships the Contractor creates to support his/her services to the District under this Contract.

**51) INDEMNIFICATION**

(a) To the extent permitted by Florida law, the Contractor must indemnify and hold harmless the District, and its officers and employees, from liabilities, damages, losses, and costs, including, but not limited to, reasonable attorneys' fees, to the extent caused by the negligence, recklessness, or intentionally wrongful conduct of the Contractor and other persons employed or utilized by the Contractor in the performance of the Agreement. The Agreement does not constitute a waiver of sovereign immunity or consent by the district or its subdivisions to suit by third parties.

(b) The District shall provide all available information and assistance that the Contractor may reasonably require regarding any claim. In the event of a claim, the District must promptly notify the Contractor in writing by prepaid certified mail (return receipt requested) or by delivery through any nationally recognized courier service (such as federal express or ups) which provides evidence of delivery, at the address provided for receipt of notices in this Agreement.

(c) This Agreement for indemnification shall survive termination or completion of the Contract. The insurance coverage and limits required in this Contract may or may not be adequate to protect the District and such insurance coverage will not be deemed a limitation on the Contractor's liability under the indemnity provided in this section. In any proceedings between the parties arising out of or related to this indemnity provision, the prevailing party shall be reimbursed all costs, expenses and reasonable attorney fees through all proceedings (at both trial and appellate levels).

(d) Nothing in this Agreement shall be deemed to affect the rights, privileges and immunities of the District as set forth in Florida statutes, Section 768.28. The terms of this section survive the termination of this Agreement.

(e) Further, the Contractor shall fully indemnify, defend, and hold harmless the District, from any suits, actions, damages, and costs of every name and description, including attorneys' fees, arising from or relating to violation or infringement of a trademark, copyright, patent, trade secret or intellectual property right.

## INSURANCE REQUIREMENTS

The successful bidder shall procure and maintain, during the life of this Contract, the following types of insurance coverage and shall furnish certificates representing such insurance to the District. The policies of insurance shall be primary and written on forms acceptable to the District and placed with insurance carriers approved and licensed by the Insurance Department in the State of Florida and meet a minimum financial AM Best and Company rating of no less than "A- Excellent: FSC VII." No changes are to be made to these specifications without prior written approval by the Administrator or designee. The Administrator or designee may alter the amounts or types of insurance policies required by this Contract upon agreement with the successful bidder.

**WORKERS COMPENSATION:** Coverage to apply for all employees for Statutory Limits in compliance with the applicable state and federal laws. The policy must include proof of current Worker's Compensation coverage. If the Bidder is exempt from Worker's Compensation per state statute, a current copy of the exemption needs to be submitted with the bid.

**COMPREHENSIVE COMMERCIAL GENERAL LIABILITY:** Occurrence form required. Aggregate must apply separately to this Contract/job. Minimum \$1,000,000 each occurrence; \$1,000,000 general aggregate; \$1,000,000 products and completed ops; and \$100,000 damage to rented premises. The District is to be named additional insured.

**BUSINESS AUTOMOBILE LIABILITY:** To include all vehicles owned, leased, hired and non-owned vehicles with limits of not less than \$1,000,000 per each accident and for property damage and bodily injury, with Contractual liability coverage for all work performed under this agreement.

**GARAGE KEEPERS:** Garage Keepers insurance coverage providing full protection for all damage to the District's vehicle(s) while in the care, custody or control of the contractor or vendor. Such coverage shall cover all loss caused by perils including but not limited to fire, lightning, explosion, theft, mischief, vandalism, collision or overturn.

All insurance policies must be issued by companies of recognized responsibility licensed to do business in Florida and must contain a provision that prohibits cancellation unless the District is provided notice as stated within the policy. It is the Contractor's responsibility to provide notice to the District.

### A. SPECIAL REQUIREMENTS:

- i. **Occurrence Basis:** All policies required by this Contract, with the exception of Workers' Compensation, are to be written on an occurrence basis. Claims Made Policies will be accepted for professional and hazardous materials and such other risks only as authorized by the District's Purchasing Office. All Claims Made Policies contributing to the satisfaction of the insurance requirements herein shall have an extended reporting period option or automatic coverage of not less than two (2) years. If provided as an option, the Contractor agrees to purchase the extended reporting period on cancellation or termination unless a new policy is affected with a retroactive date, including at least the last policy year.
- ii. **Additional Insured:** All policies required by this Contract, with the exception of Workers' Compensation, **shall name the Englewood Water District, its Board Members, officers, agents, and employees as additional insureds** as their interest may appear under this Contract. This MUST be written in the description of operations section of the insurance certificate, even if there is check-off box on the insurance certificate. Any costs for adding the District as "additional insured" shall be at the Contractor's expense.
- iii. **Certificates of Insurance:** All certificates of insurance must be on file with and approved by the District before commencement of any work activities under this Contract. All certificate(s) of insurance

required herein must be accompanied by a copy of the additionally insured documents/endorsements. Certificates of Insurance evidencing claims made or occurrences.

Form coverage and conditions to this Contract, as well as the contract number and description of work, are to be furnished to the District's Purchasing Office prior to commencement of work AND a minimum of thirty (30) calendar days prior to expiration of the insurance contract when applicable. The Certificate of Insurance issued by the underwriting department of the insurance carrier shall certify compliance with the insurance requirements provided herein.

- iv. Premiums and Deductibles: The Contractor shall be solely responsible for payment of all premiums for insurance contributing to the satisfaction of this Contract and shall be solely responsible for the payment of all deductibles and retention to which such policies are subject, whether or not the District is an insured under the policy. The Contractor's insurance is considered primary for any loss regardless of any insurance maintained by the District. The Contractor is responsible for all insurance policy premiums, deductibles, SIR (self-insured retentions) or any loss or portion of any loss that is not covered by any available insurance policy.
- v. Waiver of Subrogation: The Workers Compensation policy is to be endorsed with a waiver of subrogation. The insurance company, by proper endorsement or through other means, agree to waive all rights of subrogation against the District, its officers, officials, agents, employees and affiliates, and the District's insurance carriers, for losses paid under the terms of these polices that arises from the contractual relationship or work performed by the Contractor for the District. It is the Contractor's responsibility to notify each insurance company of the Waiver of Subrogation and request written authorization or the proper endorsement. Additionally, the Contractor, its officers, officials, agents, employees, and any subcontractors, agree to waive all rights of subrogation against the District, its officers, officials, agents, employees, affiliates and volunteers, and the District's insurance carriers for any losses paid, sustained or incurred, but not covered by insurance, that arise from the contractual relationship or work performed. This waiver also applies to any deductibles or self-insured retentions for which the Contractor or its agents may be responsible for.

## B. POLICY FORM

- 1) All policies, required by this Agreement, with the exception of Workers Compensation, are to be written on an occurrence basis, shall name the Englewood Water District, its Board Members, officers, agents, and employees as additional insured as their interest may appear under this Agreement.
- 2) Insurance requirements itemized in this Agreement, and required of the Contractor, shall be provided by or on behalf of all Subcontractors to cover their operations performed under this Agreement. The Contractor shall be held responsible for any modifications, deviations, or omissions in these insurance requirements as they apply to Subcontractors.
- 3) Each insurance policy required by this Agreement shall:
  - 1. Apply separately to each insured against whom claim is made and suit is brought, except with respect to limits of the insurer's liability.
  - 2. Be endorsed to state that coverage shall not be suspended, voided or cancelled by either party except after notice is delivered in accordance with the policy provisions. The Contractor is to notify the District's Purchasing Department by written notice via certified mail, return receipt requested.
- 4) The District shall retain the right to review, at any time, coverage, form, and amount of insurance.

- 5) The procuring of required policies of insurance shall not be construed to limit Contractor's liability nor to fulfill the indemnification provisions and requirements of this Agreement. The extent of Contractor's liability for indemnity of the District shall not be limited by insurance coverage or lack thereof, or unreasonably delayed for any reason, including but not limited to, insurance coverage disputes between the Contractor and its carrier.
- 6) The Contractor shall be solely responsible for payment of all premiums for insurance contributing to the satisfaction of this Agreement and shall be solely responsible for the payment of all deductibles and retentions to which such policies are subject, whether or not the District is an insured under the policy.
- 7) Claims Made Policies will be accepted for professional and hazardous materials and such other risks as are authorized by the District's Purchasing Department. All Claims Made Policies contributing to the satisfaction of the insurance requirements herein shall have an extended reporting period option or automatic coverage of not less than two (2) years. If provided as an option, the Contractor agrees to purchase the extended reporting period on cancellation or termination unless a new policy is affected with a retroactive date, including at least the last policy year.

Certificates of Insurance evidencing Claims Made or Occurrences form coverage and conditions to this Agreement, as well as the agreement number and description of work, are to be furnished to the District's Purchasing Department prior to commencement of work AND a minimum of thirty (30) calendar days prior to expiration of the insurance contract when applicable. All insurance certificates shall be received by the District's Purchasing Department before the Contractor will be allowed to commence or continue work.
